info@osf.org.ua www.peg.org.ua www.osf.org.ua In November 2016 the Ukrainian Parliament adopted a series of laws that improve the regulatory climate. The law On Peculiarities of State Supervision (Control) in the Economic Sector (1707-VIII) was designed to balance deregulation objectives and consumer protection provisions, as well as to implement EU law. Previously introduced global moratorium on inspections created risks to the implementation of the EU-Ukraine Association Agreement and restricted the interests of the exporters. PEG experts had warned about these risks in August of 2015. A new law contains the exhaustive list of circumstances for inspection, the list of inspecting bodies, as well as regulatory authorities.

The law amending certain laws of Ukraine to improve legislation in the sphere of state supervision (control) (1727-VIII) will add to transparency of the inspections. The law provides, inter alia, the creation of an integrated system of state supervision (control) including information on all activities undertaken, and the introduction of a single procedure for administrative sanctions.

The law amending certain laws of Ukraine to remove administrative barriers to exports of services (1724-VIII) simplifies external economic activity of small and medium businesses. The contracts will be made electronically or by accepting a public offer. Only the English text of the contract should be provided to the bank. The certificates of completion are no longer required to confirm the banking operations. The terms of currency exchange regulations had been revised.

ENERGY EFFICIENCY: IN SLOW MOTION

In November 2016 the Verkhovna Rada of Ukraine managed to adopt two bills on alternative energy.

The law on amending Article 8 of the Law of Ukraine On Alternative Fuels (1713-VIII) simplifies the business activities in the field of biofuels by abolishing the requirement of keeping a register of producers of liquid biofuels and biogas.

The law on amending the Law of Ukraine On Alternative Energy Sources to include heat pumps to equipment that uses renewable energy sources (1711-VIII) aims to implement the Directive 2009/28/EC of the European Parliament and of the Council on the promotion of the use of energy

from renewable sources in accordance with Ukraine's obligations under the Treaty establishing the Energy Community.

At the same time, the bill On the Energy Efficiency of Buildings (4941) did not get enough votes and was sent for revision to the relevant Committee. This bill is crucial to launch the Energy Efficiency Fund. The alternative bill On the Energy Characteristics of Buildings (4941-1) was registered immediately after the failed vote.

TRANSPORT: THE APPROXIMATION TO EU LAW SUSPENDED

Parliamentary Transport Committee provided negative assessments of two Cabinet of Ministers' bills:

- On Rail Transport of Ukraine (4593).
- On amending certain automotive transport acts of Ukraine to harmonize them with the EU regulatory acts **(4683)**.

In the opinion on the bill On Rail Transport of Ukraine the PEG experts drew attention to a number of shortcomings that were not conducive to the implementation of EU law, namely:

• The bill establishes mostly conceptual directions of lawmaking in the field of rail transport instead of providing effective control mechanisms. It also provides many reference rules.

- Some definitions do not meet EU directives terminology.
- The licensing for rail transport provided by the bill does not correspond with the EU law.
- The bill does not implement the principle of independence of railway operators.

The bill amending certain automotive transport acts of Ukraine to harmonize them with the EU regulatory acts aimed at the implementation of 13 EU directives and was rather voluminous. The experts expressed numerous concerns regarding the norm-making technique and the use of terminology.

PROGRESS IN LAWMAKING

Laws adopted:

- On amending the Law of Ukraine On Alternative Energy Sources to include heat pumps to equipment that uses renewable energy sources (1711-VIII).
- On amending Article 8 of the Law of Ukraine On Alternative Fuels (1713-VIII).
- On Peculiarities of State Supervision (Control) in the Economic Sector (1707-VIII).
- On amending certain laws of Ukraine to improve legislation in the sphere of state supervision (control) (1727-VIII).
- On amending certain laws of Ukraine to remove administrative barriers to exports of services (1724-VIII).
- On amendments the Law of Ukraine On Principles of State Supervision (Control) in the Economic Sector on liberalization of state supervision (1707-VIII).

Returned for revision to the committee after consideration at the plenary session:

• On the Energy Efficiency of Buildings (4941).

Returned for revision by the specialized committee:

- On Rail Transport of Ukraine (4593).
- On amending certain automotive transport acts of Ukraine to harmonize them with the EU regulatory acts (4683).

EXPERT RECOMMENDATIONS

Given Ukraine's commitments under the EU-Ukraine Association Agreement and today's dynamics of lawmaking, the PEG experts recommend the following measures to improve the quality and speed up the process of adapting the national legislation to EU law:

- 1) The Rules of Procedure of the Verkhovna Rada of Ukraine should envisage a mandatory opinion on compliance with the Association Agreement and EU law, such opinion to be attached to every bill registered in the Parliament.
- **2)** The Parliament should speed up consideration of European integration bills submitted by the Cabinet and MPs (the list is attached).
- **3)** Special attention should be paid to the approximation of legislation on intellectual property protection, transport and energy efficiency.
